CONDITIONS OF ENTRY: FASHION

Eligibility

- All entrants must be financial members of Creative Fibre (a dressmaker employed need not be a financial Creative Fibre member).
- Entries executed in a class of instruction under the guidance of a tutor are not eligible.
- We encourage the submission of a brief statement about the piece to accompany articles.
- Entries should not previously have been exhibited at a National level.
- Items must have been completed within the 12 months prior to the event.

The following criteria must be fulfilled:

- The entry must involve the creation of a new yarn, textile or object using fibre.
- If entering hand spun yarn, hand-woven or felted fabric, please state end use.
- If the piece is for sale, a fibre content and care label is also required to be attached. (Available for purchase from your Area Delegate)
- Please do not attach any other labels to your entries (especially no names or addresses).
- Wall hangings must be ready to hang and floor rugs must have provision for hanging.
- If you are not using an original design, please acknowledge your source.
- Fashion garments are eligible for National Exhibitions but must be suitable for static display.
- Please include 5cm square Touch Samples of yarn, fibre or fabric these will be available for the selectors and so public may appreciate the tactile nature of our work.
- Non-compliance with these requirements will render your entry not eligible for selection.

Sizing – It is recommended outfits be made to a basic NZ size:

Please do not send any items that are not part of your entry, eg. jewellery.

Insurance

While in transit and throughout the festival, insurance is the responsibility of the entrant, as is GST if applicable. NB. Fashion garments, must be constructed well, as they will be taken on and off models many times during selection and shows.

Overseas Entries

- Please be aware that sending your entry to New Zealand may incur GST (New Zealand Goods and Services Tax), duty and brokerage. Please contact your customs agent for details. All expenses will be the responsibility of the entrant.
- Direct credit payments from Creative Fibre may incur extra charges and will be passed on to the entrant.

Selection

All work will be subject to selection and the selectors' decision is final. No correspondence will be entered into about any specific entry.

Awards

All entries will be considered for the appropriate awards. Trophies must not be removed from New Zealand.

All reasonable care will be taken with entries
